Development – Guarantee Fund of Brčko District BIH (concretely Unit for Implementation of International Projects, City of Loznica and Insititute for Development and Innovation IRI are implementing project titled as: "NEwly established Start-up Enterprise SERvices" – abreviation NESESER – as a project designed and approved by Cross-border Programme Serbia-Bosnia and Herzegovina 2014-2020 implemented under the framework of the Instrument of Pre-accession Assistance (IPA II) and is the result of joint planning efforts made by the governments and other stakeholders of the two countries.
